3. Accordingly, this Criminal Miscellaneous Petition is allowed.

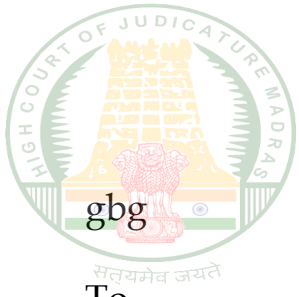
