PRAYER: Writ Petition filed under Article 226 of the Constitution of India for issuance of Writ of Mandamus to direct the first respondent to dispose the petitioner's pending appeal *vide* their proceedings in Na.Ka.D1/2798/2025 against the second respondents order in Moo.Mu.Aa1/6472/2024, dated 10.12.2024 within the stipulated time limit as fixed by this Hon'ble Court and consequently, direct the fourth respondent by restraining him from making any encumbrance against the petitioner's own properties with the third parties based on the petitioner's settlement deeds *vide* the third respondents documents Nos. 3588/2010 dated 26.11.2010 and 1/2120/2024 dated 03.06.2024.
