ORDER

This writ petition has been filed seeking a direction to the respondents to issue the patta in connection with Survey No. 280/5 to an extent of 28 Ares 280/6 to an extent of 823 Ares situated at Nasar Puliyanakulam Village, Mustakurichi Panchayat, Kariyapatti Taluk, Virudhunagar District, on the basis of the petitioner's representation dated 20.04.2023 within a time frame to be stipulated by this Court.

2. Heard the learned counsel for the petitioner and the learned Additional Government Pleader appearing for the respondents.

3. The petitioner submitted a representation on 20.04.2023 to the respondents for issuance of patta for the petitioner's land. However, no action has been taken on the said application. Hence, the present writ petition has been filed.

4. Learned Additional Government Pleader, appearing for the respondents, submits that the representation of the petitioner would be
