Hence, the petitioner has come before this Court.

5. The learned Government Advocate appearing for the respondents 1 & 2 would submit that application of the petitioner will be considered in accordance with law.

In view of the same, without expressing any opinion on the merits of the matter, the respondents 1 & 2 are directed to consider the online application of the petitioner dated 12.08.2024 and pass final orders on its own merits, within a period of eight weeks from the date of receipt of a copy of this order, after issuing notice to the petitioner, neighbouring land owners and other interested parties.
