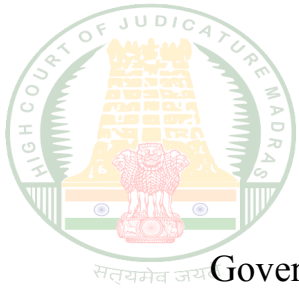

3. The writ petition stands disposed of with the above direction.

There shall be no order as to costs. Consequently, connected Miscellaneous Petition stands closed.
