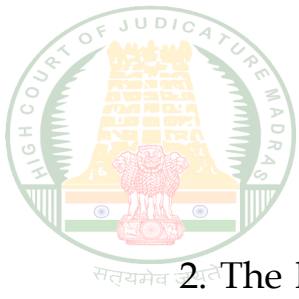
PRAYER :- To relax the condition imposed on the petitioner by this Court in its order,
