ORDER

This Criminal Original Petition has been filed seeking to quash the final report in S.C.No.414 of 2024 filed for the offences under Section 417, 376, 294(b) and 506(1) of IPC.

2. The allegation in the final report is that on the promise of marriage, the petitioner enticed the defacto complainant and had sexual intercourse and had also received cash to the tune of Rs.5,00,000/- and thus committed the aforesaid offences.

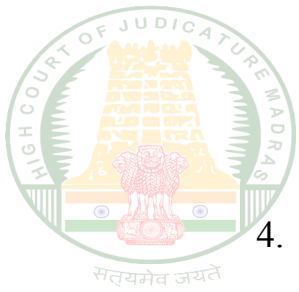
3. When the matter came up for admission, this Court had passed the following order:

“8. The learned Additional Public Prosecutor, on instructions, would submit that the defacto complainant has applied for compensation of Rs.1.75 Lakhs and she is willing to resolve the issue provided she receives compensation.

9. Upon considering the facts and circumstances of the case, this Court is of the opinion that it is a fit case to be referred for mediation.

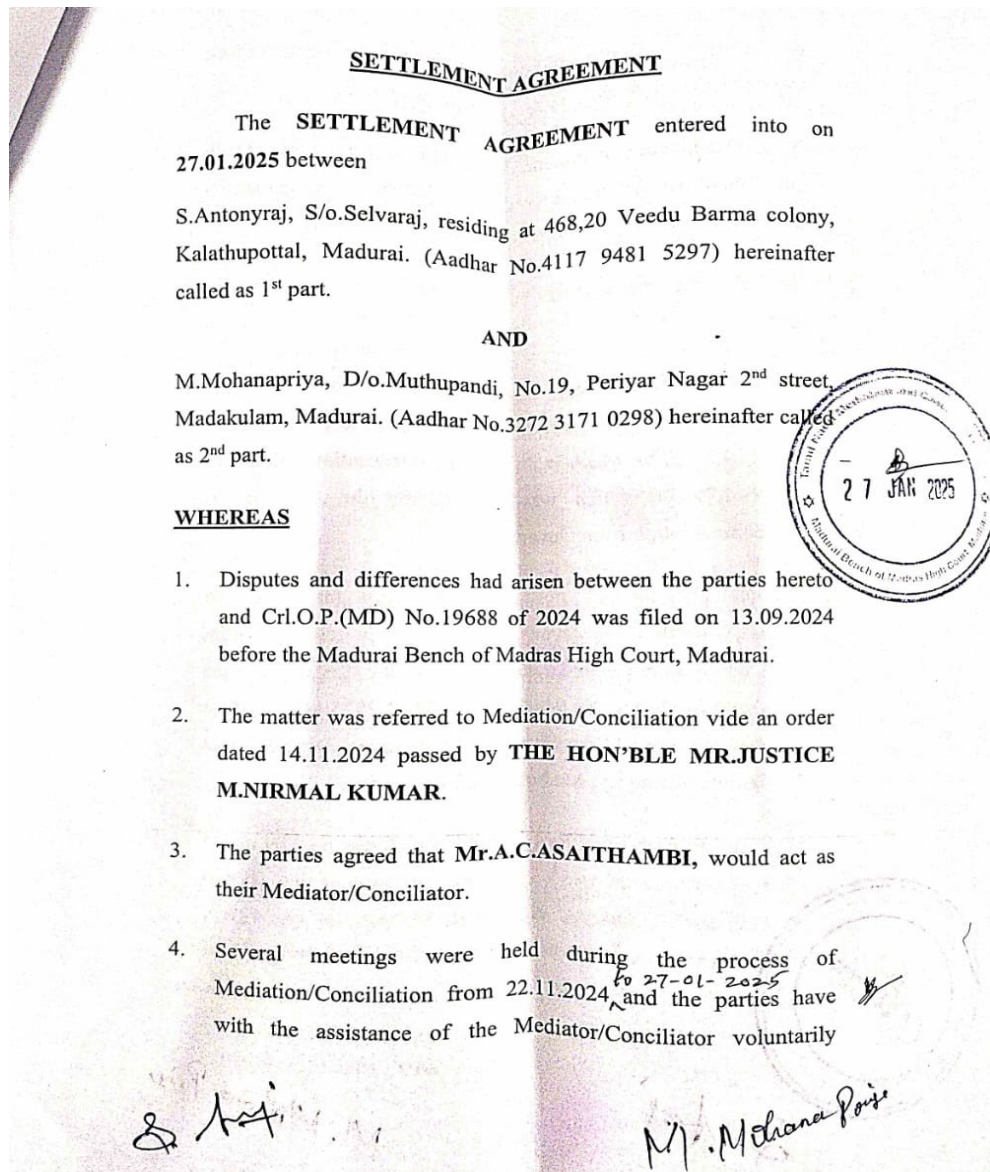
10. Let both parties shall appear before the Mediation and Conciliation Centre attached to this Bench on 21.11.2024.

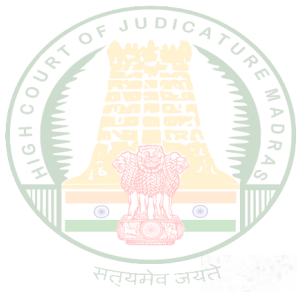
11. Registry to list this matter before this Court along with mediation report.”

4. The parties therefore had appeared before the Mediation Centre attached to this Court. During the mediation, the parties arrived at a settlement and entered into a settlement agreement dated 27.01.2025. The scanned copy of the said settlement agreement reads as follows:

arrived at an amicable solution resolving the above-mentioned disputes and differences.

5. The parties hereto confirm and declare that they have voluntarily and of their own free will arrived at this Settlement Agreement in the presence of the Mediator/Conciliator.

6. The following settlement has been arrived at between the parties hereto:

- a. It is agreed that the 1st part and the 2nd part had settled the issue amicably that the 1st part was ready to pay a sum of Rs.4,25,000/- which includes the compensation amount of Rs.1,75,000 which was received by the 2nd part as compensation from Government.
- b. The 1st part had took a demand draft for a sum of Rs.1,75,000/- in favor of Member Secretary, Victim Compensation Fund, Tamilnadu State Legal Services Authority in DD No.944804 dated 23.01.2025 and the same was entrusted to the Secretary / Sub Judge, District Legal Service Authority, Madurai on 23.01.2025.
- c. Apart from the said Rs.1,75,000/- which was paid by the 1st part towards 2nd part's compensation amount, the 1st part had also remitted a sum of Rs.50,000/- on 06.05.2024 through Gpay (UPI Transaction Id:449339495584), today i.e., 27.01.2025, the 1st part had paid a sum of Rs.2,00,000/- through RTGS to the account (A/c No.552502010014313

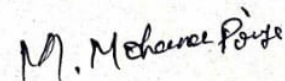
Union Bank of India, Narimedu Branch, Madurai) of the 2nd part on 27.01.2025 and the 2nd part had also acknowledged the same.

- d. By accepting the payment of Rs.4,25,000/-, the 2nd part is ready to give no objection for quashing the FIR in Crime No. Crime No. 24 of 2023 on the file of the All-Women Police Station, Thilagarthidal, Madurai City and the subsequent proceedings in S.C.No.414 of 2024 on the file of District and Sessions Court, Mahila, Madurai by appearing in person before this Hon'ble Court in Crl.O.P.(MD) No.19688 of 2024 during next date of hearing or on the subsequent hearings.
7. By signing this agreement, the parties hereto state that they have no further claims, demands against each other, interfere in each other's life with respect to Crl.O.P.(MD) No.19688 of 2024 and all disputes and differences in this regard have been amicably settled by the parties hereto through the process of conciliation/mediation.

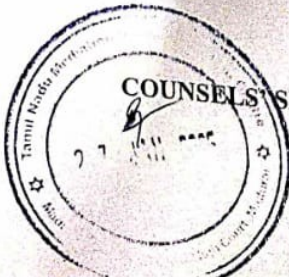

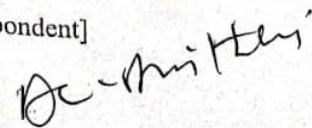

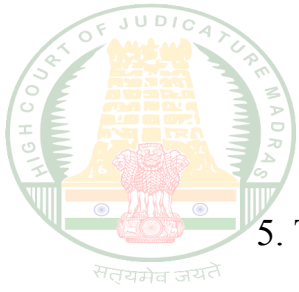

5. The petitioner, namely, S.Antonyraj (Aadhaar No.4117 9481 5297) and the defacto complainant, namely, M.Mohanapriya (Aadhaar No.3272 3171 0298) are present before this Court in person and they are identified by M/s.S.Shyamaladevi, Special Sub Inspector of Police, All Women Police Station, South, Madurai City. The defacto complainant confirms that the parties have arrived at a settlement and states that she has no objection in quashing the impugned proceedings.

6. In view of the aforesaid facts and considering the nature of relationship between the parties and the compromise arrived at between them, this Court is of the view that no useful purpose would be served in keeping the impugned proceedings pending. Accordingly, the impugned final report in S.C.No.414 of 2024 on the file of the District and Sessions Court (Mahila), Madurai is quashed and the Criminal Original Petition is allowed. Consequently, connected miscellaneous petition is closed.
