Munsif Cum Judicial Magistrate, Avudaiyarkoil, Pudukottai district, in



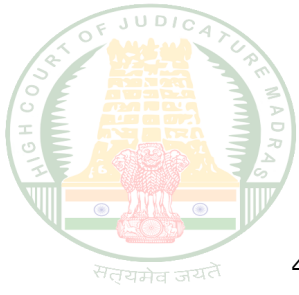
