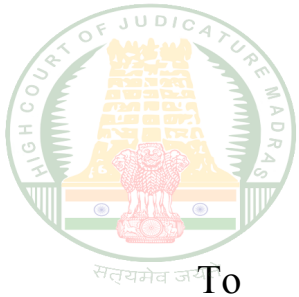
The petitioner has approached this Court to quash the FIR registered against her in Crime No.482 of 2025 on the file of the 1<sup>st</sup> respondent.
