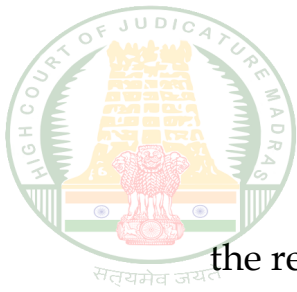

ORDER

The Petitioner herein seeks a direction to the first respondent to dispose of the appeal pending on his file in Na.Ka.NO.A3/5176/2024, dated August,2024 challenging the proceedings of the second respondent in O.Mu.A4/806/2024, dated 13.5.2024.

2.Mr..Baskaran, learned Additional Government Pleader takes notice for the respondents 1 to 3. By consent of both parties, the Writ Petition is taken up for final disposal at the admission stage itself.

3.It is the case of the Petitioner that he filed an appeal before the first respondent in Na.Ka.NO.A3/5176/2024, dated August, 2024 seeking cancellation of patta issued in favour of private respondents and the same has not been considered so far. 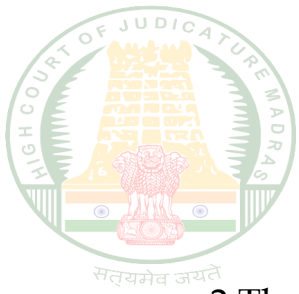
