2.Learned Counsel for the petitioner would submit that the petitioner filed a suit for specific performance as against the respondent / defendant in O.S.No.100 of 2024, on the file of the (*)Additional District Court, (FTC) Theni, in which the petitioner also filed I.A.No.1 of 2024, for interim injunction restraining the defendant not to alienate the property. Thereafter, the trial Court granted an order of *status quo* on 03.02.2025. However, I.A.No.1 of 2024 was wrongly typed as I.A.No.1 of 2025, for which the petitioner filed unnumbered I.A.No. /2025, for rectification. However, the same was returned and again re-presented but no order was passed. Hence, the present Civil Revision Petition has been filed.

3.Since no adverse orders are passed in the present Civil Revision Petition, notice to the respondent is dispensed with.

4.Considering the facts and circumstances of the case, there shall be a direction to the Additional District Court (FTC), Theni, to number the unnumbered I.A. for rectification of the error and dispose of the same.
