2.The learned counsel for the petitioner would submit that since the suit was dismissed as against the sole defendant, she filed an appeal. During the pendency of the appeal, the appellant died and hence, her husband and daughter were impleaded as appellants and that the appeal was dismissed. Subsequently, the daughter of the original defendant died, and as such, the husband of the original defendant, the first appellant, filed the second appeal. He would further submit that the deceased Ramya Vihasini executed a will in favour of her father Velayutharaja.
