ORDER : The Court made the following order :-

This petition has been filed for extension of time for compliance of the conditional order passed in Crl.O.P(MD).No.10796 of 2025 dated 04.07.2025.

2. The learned Counsel for the petitioners would submit that this Hon'ble Court passed an order in Crl.O.P(MD).No.10796 of 2025 dated 04.07.2025 and enlarged the petitioners on anticipatory bail by imposing certain conditions. He further submits that due to unavailability of sureties, the petitioners are unable to produce sureties before the concerned Court within the time stipulated by this Court. For the said reason only, they are unable to comply the conditions imposed by this Court in Crl.O.P.(MD).No.10796 of 2025 dated 04.07.2025.
