**Prayer :-**

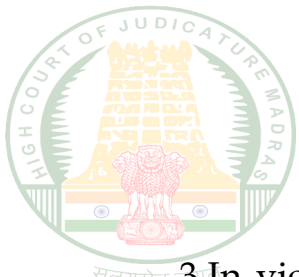
