ORDER

The Writ Petition is filed seeking a direction to the respondents to survey the properties in S.Nos.146/6A and 146/6B situated at Silvarpatti Village, Dindigul West Taluk, Dindigul District by considering the Petitioner's online application, dated 22.5.2025.

2.Mr.M.Gangatharan, learned Government Advocate takes notice for the respondents 1 and 2. By consent of both parties, the Writ Petition is taken up for final disposal at the admission stage itself.

3.According to the Petitioner, the subject property originally belongs to the Petitioner's father Chinnasamy Thevar. After his death, revenue patta for the same stands in the name of Petitioner and other legal heirs of Petitioner's father Chinnasamy Thevar in Patta Nos.384 and 1068. The Petitioner submitted an online application on 22.5.2025 seeking survey of the subject property. However, till date the same has not been considered. Hence the

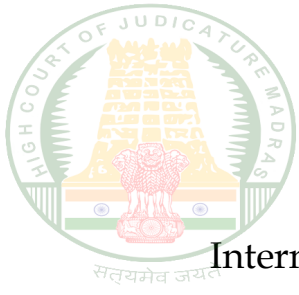
