ORDER: The Court made the following order :-

This petition has been filed for extension of time for compliance of the conditional order passed in Crl.O.P(MD).No.9717 of 2025 dated 07.07.2025.

2. The learned Counsel for the petitioner would submit that this Hon'ble Court passed an order in Crl.O.P(MD).No.9717 of 2025 dated 07.07.2025 and enlarged the petitioner on anticipatory bail by imposing certain conditions. He further submits that another FIR was registered against this petitioner herein in Crime No.186 of 2025. Hence, this petitioner has filed an anticipatory bail petition before this court in Crl.O.P.(MD).No.11779 of 2025, therefore, he was not able to arrange for sureties in time in the present case.
