3.According to the petitioner, the property situate in the above mentioned survey number with an extent of 6.65 acres belongs to his family. There is a water channel running through the properties of the petitioner's family and its location has not been properly depicted in the FMB for the above mentioned survey numbers. Therefore, the petitioner submitted the representation dated 02.07.2025 seeking correction in the FMB. The said representation has not been considered. Hence he has come before this Court.

4.The learned Government Advocate who takes notice for the respondents would submit that the representation submitted by the petitioner will be considered in accordance with the law.

5.In the view of the same, without expressing any opinion on the merits of the matter, the second respondent is directed to consider the

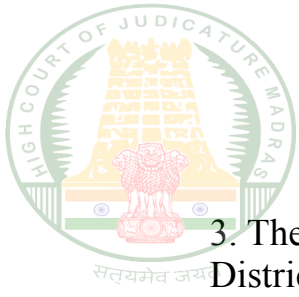
