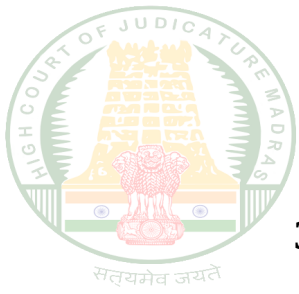

ORDER

2.The learned Government Advocate(Crl.side) appearing for the respondents submits that based on the complaint forwarded by the learned Magistrate, the respondent Police has conducted enquiry and found that the complaint of the petitioner has not constituted any cognizable offence and hence, a report has been placed before the learned Magistrate, on 26.07.2025.
