ORDER

2.Mr.P.Kottaichamy, learned Government Advocate (Crl.side), who takes notice for the first respondent submits that the investigation in Crime No.285 of 2024 has already been completed and final report has also been filed before the Judicial Magistrate Court No.II, Virudhunagar, through e-filing No.C202500022, on 02.01.2025.
