ORDER

This Writ Petition has been filed seeking a direction to the respondents to Survey and demarcate four boundaries by planting survey stones in Survey No.406/26, to an extent of 0.2.00 Ares which is situated at Mudukulam Village, South Street, Kantharvakottai, Puthukottai District, by considering the online application of the petitioner dated 08.07.2025.

2. According to the petitioner, the subject property was purchased by grandfather of the petitioner's husband, namely, Savarimuthu, through a registered sale deed dated 06.06.1983 and the patta for subject property stands in the name of the petitioner's husband namely, Arockiyaraj in Patta No.103. The petitioner filed an online application on 08.07.2025 in Application No.2025/N123/22/008126 seeking survey of the property. Since the same has not been considered, she has come before this Court.
