3.Recording the submission made by the learned Government Advocate (Crl.side), this Criminal Original Petition is closed with liberty to the petitioner to challenge the final report, if so advised, in the manner known to law. Mere filing of final report is not sufficient and it is the responsibility of the respondent police to ensure that the final report is taken on file by the concerned Court within a
