2.Dr.Alagumani, learned counsel seeks permission of this Court to withdraw this petition and he has also made an endorsement to that effect. Further he would seek liberty to file appropriate petition against her grievance.

3.The prayer in the writ petition was challenging the order of transfer of the petitioner's husband from Palayamkottai Prison to Trichy Prison and consequently, seeking for a direction.



4. During the course of argument, this Court wanted to know about the measures initiated by the Prison Department and the training given to the prisoner in various jail. A report was filed before this Court, which was taken on file. While so since the submission was made by Dr. Alagumani, learned counsel that he was ready to furnish the details with regard to various courses conducted by the Prison Department in the nearby States and he is ready to collect the particulars and hand it over to the prison authorities of Tamil Nadu. Post the matter on 26.08.2025.

5. Today when the matter is came up for hearing, Dr. Alagumani, learned counsel is not ready with the particulars.

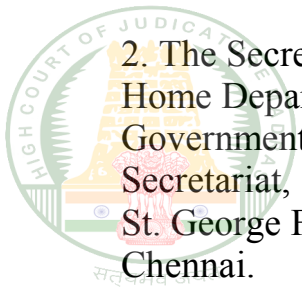
