ORDER

The Writ Petition is filed seeking a direction to the second respondent to dispose of the appeal filed by the Petitioner, dated 21.7.2025 under Section 12 of the Tamil Nadu Patta Passbook Act.

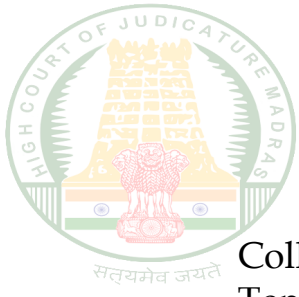
