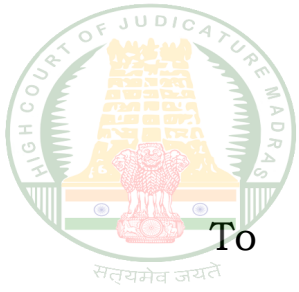
5.In view of the above, this writ petition is closed
