PRAYER : Petition filed under Article 226 of the Constitution of India praying for issuance of Writ of Mandamus, directing the respondent to pay the petitioner the amount towards the encashment of 64 days of earned leaves surrendered by him in the years before his retirement either based on his monthly wages of the respective months of surrender of those earned leaves, together with 18% interest p.a., from the respective due dates or based on the monthly wages payable on the month of his retirement, together with 18% interest from the date of his retirement within a time frame as may be fixed by this Court.

The instant writ petition is filed seeking a direction to the respondent to pay the amount towards the encashment of 64 days of earned leave surrendered by the petitioner with interest.

Thereby, the petitioner has come forward with the present writ petition.
