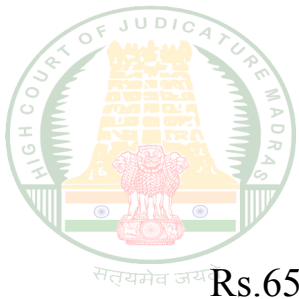

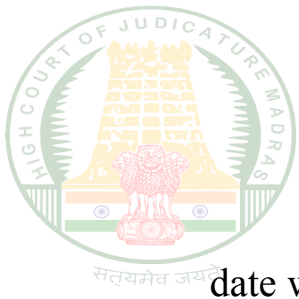

ORDER

The petitioner claiming arrears of pension and commutation amount has submitted a representation before the respondents and since the same has not been disbursed to him, he has approached this Court in the year 2019.

2.Today(30.01.2025), when this writ petition is taken up for hearing, the learned Standing Counsel appearing for the respondent Corporation submits that this petitioner has retired from service on 29.02.2008 and the basic pay of this petitioner as on that

date was Rs.10,035/-. The eligible pension benefits for the petitioner was calculated with effect from 01.09.1986, by taking into account the last drawn salary of this petitioner Rs.10,035/-. He further submits that a sum of Rs.1,46,984/- was also settled to this petitioner and the pension amount of Rs.7,674/- is paid every month as pension to the petitioner. A copy of the proceedings dated 25.10.2019 is also placed before this Court.

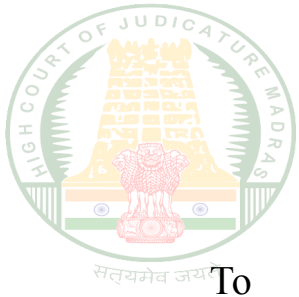
