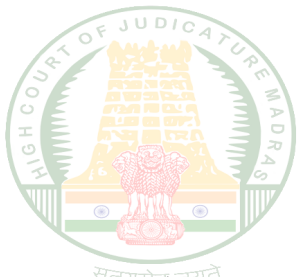
PRAYER: Criminal Original Petition filed under Section 483(1)(b) of the Bharatiya

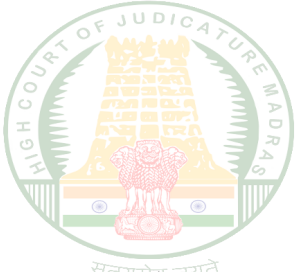
