2.Approval of the educational society is to be granted in accordance with the provisions of the relevant statutes and rules in force. More so, the Writ Petition was filed in the year 2019 and six years have since lapsed.

3.The learned Government Pleader appearing on behalf of the respondents 1 to 3 and 5 submitted that a Special Officer has been appointed.

4.Under these circumstances, if any grievance exists as of now, the petitioner is at liberty to approach the competent authorities. Moreover, the nature
