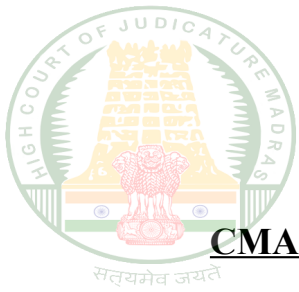

preferred Civil Miscellaneous Appeals and the same is pending for the past six years.

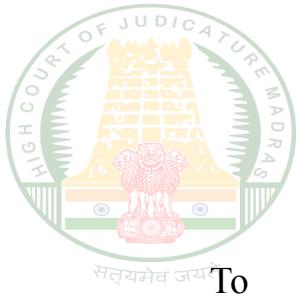
