3.In view of the above, this petition is allowed.

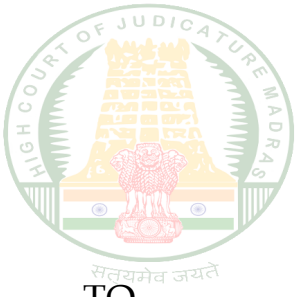
