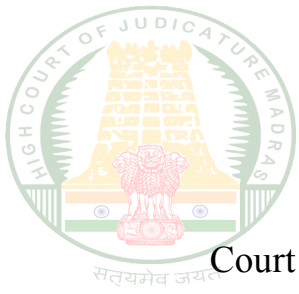
ORDER
