3. It is submitted that the last date for submitting the bid expires today and therefore, left with another option, the petitioner is approached this Court for direction to the third respondent to issue a Site Inspection Certificate.

4. The learned Government Advocate for the respondents submits that the Site Inspection Certificate will be issued by tomorrow, i.e., 26.08.2025 and that the petitioner's offer will be received and also the opening of the tender will be postponed by a day, i.e., 27.08.2025.

5. Recording the same, this Writ Petition is disposed of by directing the third respondent to issue the Site Inspection Certificate to the petitioner positively by tomorrow, i.e., 26.08.2025 at 12.00 p.m., to enable the petitioner to upload the offer duly filled with the Site Inspection Certificate. The respondents shall receive the same both electronically and in a physical copy in a sealed cover.
