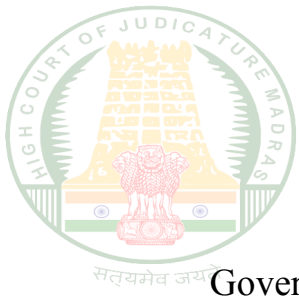

3. According to the petitioner, the subject property belongs to him and the Natham Patta for the subject property stands in his name in Patta No.522. He submitted an online application on 05.08.2025 in Application No. 2025/N123/24/011511, seeking survey of the property and the same has not been considered. Hence, the petitioner has come before this Court.

4. The learned Government Advocate appearing for the respondents would submit that the application of the petitioner will be considered in accordance with law.
