PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the respondents 1 to 6 to consider the Petitioner's representation, dated 27.1.2025 and to grant house site patta to the Petitioner for the Plot No.33, situated in S.No.81B/4, Ramamammuthiraikkottai Village, Papanasam Taluk, Thanjavur District in view of the fact that the previous allottee namely, Ramamirthamum, wife of Petchaian has passed away without heirs.

ORDER

After submitting a representation, dated 27.1.2025 for grant of house site patta to the Petitioner, the present Writ Petition has been filed.

2.Learned counsel for the Petitioner submits that the land was allotted to Ramamirthmum, wife of Petchaian, earlier and that the said Ramamirtham passed away without legal heirs. Therefore, he submits that the Petitioner's representation may be considered.

WEB COPY 3.The learned Special Government Pleader appears on behalf of respondents 1 to 6. On instructions, he submits that house site patta was issued to the Petitioner's husband's grand father. Consequently, he states that the Petitioner is not entitled thereto. Without prejudice, he submits that the representation would be considered and disposed of on merits.

4.In these circumstances, without expressing any opinion on the merits of the request, the third respondent is directed to consider and dispose of the representation, dated 27.1.2025, after providing a reasonable opportunity to the Petitioner and respondents 3 and 4, within a period of 8 weeks from the date of receipt of a copy of this order.

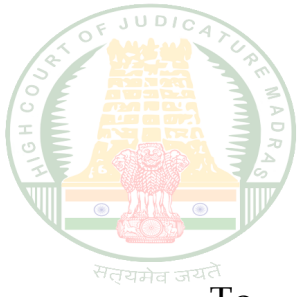
5.With the above directions, the Writ Petition stands disposed of.
