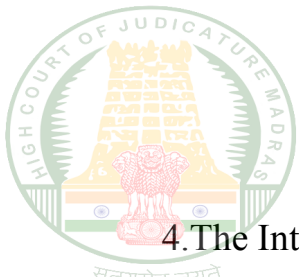

JUDGMENT

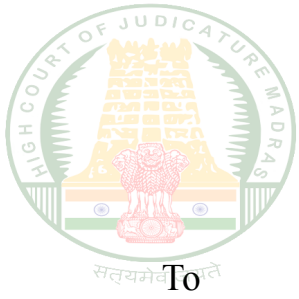
