The petitioner herein seeks a direction to the respondents to survey the property situated in Survey Nos.93/15, Sirudhur Village, Madurai North Taluk, Madurai District, by considering her application dated 27.06.2025.

2.Heard the arguments of Mr.S.Karthick Ramkumar, learned counsel appearing for the petitioner and Mrs.S.Jeyapriya, learned Government Advocate appearing for the respondents. By consent of both sides, this Writ Petition is taken up for final disposal at the admission stage itself.

3.According to the petitioner, the subject property was settled in her favour by her husband under a registered settlement deed 28.01.2025. The patta for the subject property stands in her name in Patta No.7046. The petitioner submitted an application on 27.06.2025 in Application No.2025/0123/24/017085, seeking survey of the subject property. The same has not been considered. Hence, he has come before this Court.
