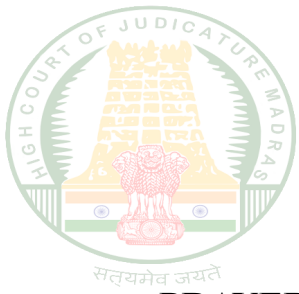

For R1 : Mr.S.Shaji Bino

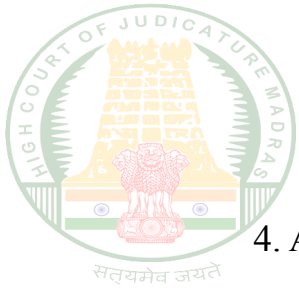
