Prayer in WP(MD)10324 of 2024:-

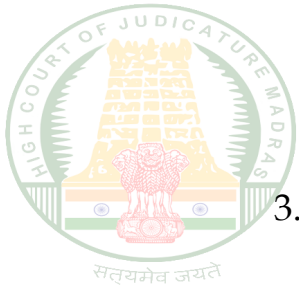
