### **ORDER**

After submitting an application dated 05.03.2025 seeking a survey of the land in New Town survey No.10/3B1A, the present writ petition has been filed.

2.Learned counsel for the petitioner relies on sale deed dated 02.02.1996 and the patta at page No.21 of the typed set.

3.Both learned Additional Government Pleader and learned Standing Counsel for the third respondent submit that they endeavoured to conduct the survey by issuing a notice to the petitioner and to the President of the Nithyanandam Swamy Kovil Trust. It is further stated that the said Trust has put up a gate and fence barring access to the relevant land. Learned Additional Government Pleader submits that the inquiry shall be conducted after putting all the affected parties on notice.
