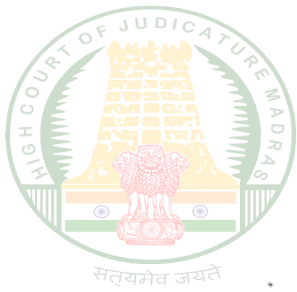

This Criminal Original Petition is filed seeking to quash the FIR in Crime No.38 of 2025 on the file of the first respondent Police, which was registered for the offences under Sections 296(b), 115(2), 303(2), 308(2), 336(2), 336(3), 340(2), 351(2) of BNS and Section 4 of Tamil Nadu Prohibition of Harassment of Women Act.

2. The allegation against the petitioner is that the petitioner took possession of the vehicle belonging to the defacto complainant for recovery of alleged dues payable by the defacto complainant to the petitioner and abused her in filthy language and also assaulted her and thus, committed the aforesaid offences.

3. The learned counsel for the petitioner and the learned counsel for the defacto complainant/the second respondent would submit that the parties have now entered into a compromise on the advise of the elders and well-wishers and both the parties have agreed that the impugned F.I.R may be quashed.

4.The parties have also filed a joint compromise memo dated 11.08.2025. The scanned copy of the compromise memo reads as follows:

JOINT COMPROMISE MEMO FILED BY THE PARTIES

1. It is submitted that the Petitioner herein has filed the present petition seeking to quash the FIR in Crime No. 38 OF 2025 pending on the file of Kattuputhur Police Station, Trichy District.

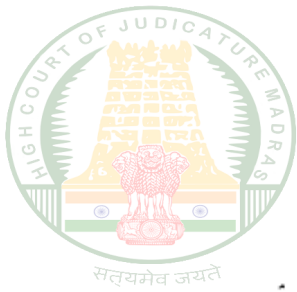

2. It is the case of the prosecution that on 29.01.2025, the de-facto complainant namely Tamilselvi after getting back her white colour maruthi swift car bearing registraion number TN 88 H 8778 from Thottiyam Judicial Magistrate Court, Tirchy. The defacto Complainant while returning back to Namakkal, she parked the vehicle near Murungai Division road after seeing the petitioner who was well known to her.
3. It is alleged in the complaint that on the same day at about 4.30 P.M, the petitioner herein had abused the defacto complainanat in filthy language and assualted her and threatened her of the dire consequences and stole her car and left the place. Hence the complaint and FIR in Cr.No.38 of 2025 was registered on the file of Respondent Kattuputhur Police for alleged offences under sections 296(b), 115(2), 303(2), 308(2), 336(2), 336(3), 340(2), 351(2) of BNS and section 4 of TNPHW Act.
4. Now the parties have entered into mutual compromise and resolve the dispute amicably.
5. That the petitioners herein and Respondent No.2 hereto do hereby declare and confirm that the joint compromise memo is executed by both the parties does not amount to any collusion on their part, and they do hereby further and once again declare and confirm that

they sincerely enter into and execute this joint compromise memo only with their full consent and final agreement.

6. The terms of joint compromise memo are

a. That the parties have resolved the dispute mutually amicably.

b. That the Respondent No.2 undertakes to withdraw the criminal case in Cr.No.38 of 2025 on the file of Kattuputhur Police Station, Namakkal District and co-operate in judicial proceedings to quash/trial of the criminal case in Cr.No.38 of 2025 on the file of Kattuputhur Police Station, Trichy District

c. There are no claims or whatsoever against each other.

7. It is submitted that no prejudice, hardship, loss or injury would be caused to us if the proceedings is quashed by this Hon'ble court in view of the mutual settlement arrived between us.

This being the case this Hon'ble Court may be pleased to take the joint compromise memo dated 11.08.2025 executed by the Respondent No.2 herein and quash the FIR in Crime No. 38 of 2025 pending on the file of Kattuputhur Police Station, Trichy District and thus render justice.

Accordingly, the impugned FIR in Crime No.38 of 2025, on the file of the first respondent police, is quashed and the Criminal Original Petition stands allowed.
