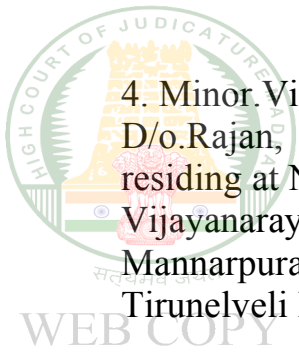

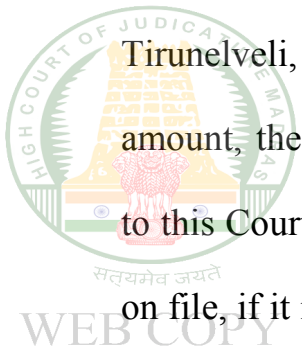
Prayer:To condone the delay of 72 days in filing the appeal in C.M.A.(MD).SR.No. 72791 of 2025.
