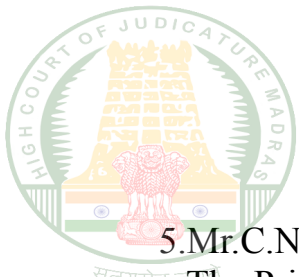

ORDER

Mr.S.Shaji Bino, learned counsel appearing for the respondents submits that against the orders passed by the learned Single Judge in the connected cases, the State preferred writ appeals and the Hon'ble Division Bench of this Court issued an order of interim stay of the order of the learned Single Judge. 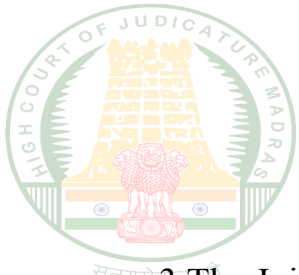
