(Judgment of the Court was made by M.S.RAMESH,J.)

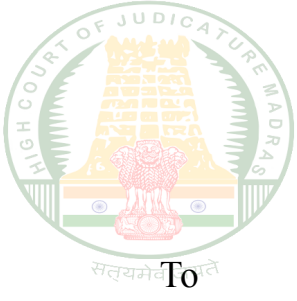
This Writ Appeal has been filed against the order of the learned Single Judge in W.P.(MD).No.18173 of 2017 dated 21.06.2024.
