No. 45/3, Ward-D, Block-14, Kottai Chokkappan Chettiyar Street, Chokkalingapuram, Aruppukkottai Town, and further directing the 4th respondent to issue patta in favour of the petitioner's wife, S. Backialakshmi, in respect of the land measuring an extent of 2673¼ sq. ft. comprised in Natham Survey No. 167/1944, now in T.S.No.45/2, Ward-D, Block-14, Kottai Chokkappan Chettiyar Street, Chokkalingapuram, Aruppukkottai Town, by considering the
