Both the parties and their respective counsels are present and they arrived at an amicable settlement for a sum of Rs.5,00,000/- [Rupees Five Lakhs only] as full quit.

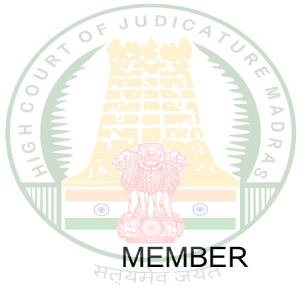
