5. Accordingly, this Writ Petition is disposed of. No costs.

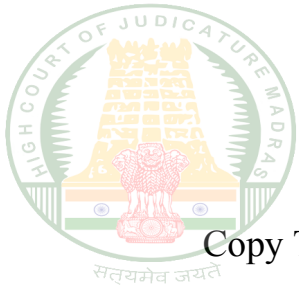
