ORDER

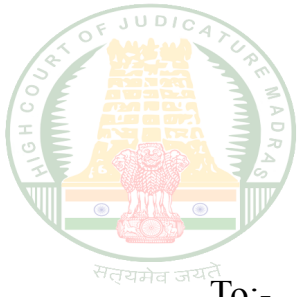
The learned counsel for the petitioner seeks permission of this Court to withdraw this writ petition with liberty to file a fresh writ petition confining his prayer.
