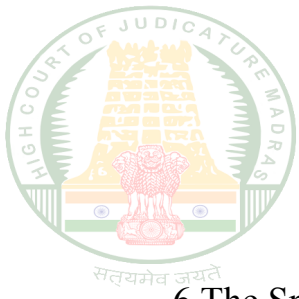

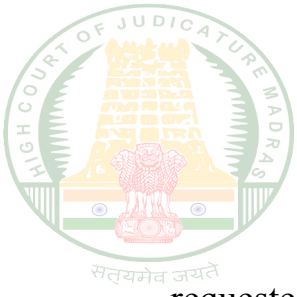

requested this Court to permit him to withdraw this Petition and he also made an endorsement to that effect.

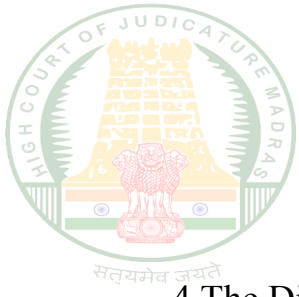
2. In view of the letter dated 05.02.2025 and the endorsement made by the learned counsel for the petitioner, this Writ Petition is dismissed as withdrawn.
