this Court passed the following

### **ORDER**

#### **Prelude:**

*“This dedicated bench is for implementing the pilot project to identify and dispose of criminal cases involving offences punishable with imprisonment up to 3 years pending at trial, appeal or revision stage for more than 3 years and also offences like Section like Section 506(ii) of*

*IPC and others, which may carry a punishment of more than 3 years in the State of Tamil Nadu with reference to the 14 Districts coming under the Madurai Bench of Madras High Court.”*

2.This Dedicated Bench has taken the **S.C.No.393 of 2021 on the file of the Principal Sub Court, Madurai Taluk, Maduai, as *Suo motu* Special Tr.Case.(MD) No.7588 of 2025** in *Suo Motu* W.P.(Crl.).(MD).No. 1014 of 2025, upon proper scrutiny and considering its suitability that it is a fit case warranting the exercise of power under Article 226 of Constitution of India to quash the said C.C., which is pending for more than **four** years without any progress.

**3. Brief facts of the prosecution case in S.C.No.393 of 2021:**

According to the prosecution, 09.11.2014, at about 09.00 am, the accused robbed the amount of Rs.300/- from the shirt pocket of the complainant. Therefore, a case was registered in Crime No.1118 of 2014 for the offences punishable under Section 392 r/w 397 and 506(ii) of IPC. On investigation, final report has been filed and the same was taken cognizance in **S.C.No.393 of 2021** and the same is pending without trial for more than four years.

4. When the matter is taken up for hearing Mr. Ravi, the learned Additional Public Prosecutor, on instructions, would submit that Non Bailable Warrant was issued against the accused and the same was executed and the accused is produced before the **Principal Sub Court, Madurai Taluk, Madurai.**

5. The **Principal Sub Court, Madurai Taluk, Madurai**, is hereby directed to complete the trial in **S.C.No.393 of 2021** within a period of 2 months from the date of receipt of a copy of this order.

6. With the above said directions, this suo motu transfer petition stands closed.
