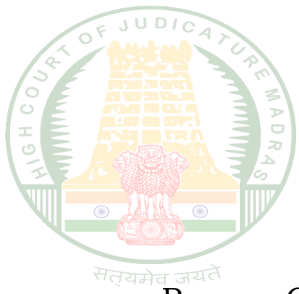

ORDER

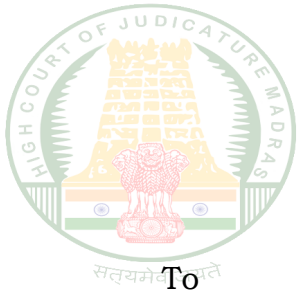
There is no representation for the petitioner.
